1. Aims

This policy aims to set out our approach to school uniform that offers the best value for money for parents and avoids discrimination in line with our legal duties under the Equality Act 2010.

2. Affordable school uniform

Our school has a duty to make sure that the uniform we require is affordable and in line with statutory <u>guidance</u> from the Department for Education (DfE) on the cost of school uniform. To ensure uniforms are available at a reasonable cost and provide the best value for money, we:

- limit items with distinctive characteristics such the school logo to low-cost or long-lasting items
- offer cheaper alternatives to school-branded items, such as iron-on logos, provided quality and durability are not compromised
- avoid specific requirements for items pupils could wear on non-school days, such as coats, bags, and shoes
- ensure that arrangements are in place for parents to acquire second-hand uniform items
- avoid frequent changes to uniform specifications
- consult with parents and pupils on any proposed significant changes to the uniform policy

3. Description of school uniform

Uniform is compulsory in all classes, including the Nursery.

Item	Specifications	
School colours	Navy blue to be worn with grey, black, and white	
Standard wear	Grey or white shirt; navy blue jumper, cardigan, or sweatshirt; black or grey trousers or skirts Jumper, cardigan, or sweatshirt must include the Stebon logo	
Summer wear	Navy blue and white check dresses Generic item accepted	
Footwear	Trainers or flat-heeled shoes or sandals in black Generic item accepted	
Jewellery	Small stud earrings and watches only (optional) but must not be worn on PE or swimming days	



Headwear	Headscarves in school colours may be worn (optional) Generic item accepted	
Indoor PE Kit	Shorts and t-shirts in school colours Generic item accepted	
Outdoor PE Kit	Warm top, jogging bottoms, trainers, additional clothing for all weather (lightweight waterproofs, warm hat, gloves, spare socks) Generic item accepted	
Swimming Kit	Appropriate swimming kits; swimming caps available via ParentPay or school office Generic items from sports shops	
Purchase (Branded)	Available from Khalsa Schoolwear and School Trends online Generic items can be obtained from local supermarkets	

4. Roles and responsibilities

4.1 Pupils

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days), including:

- on the school premises
- travelling to and from school
- at out-of-school events or on trips that are organised by the school, or where they are representing the school

4.2 Parents

Parents are expected to make sure their child has the correct uniform and PE kit, and that every item is:

- clean
- clearly labelled with the child's name
- in an appropriate condition for school

4.3 Staff

Staff will monitor to make sure pupils are in the correct uniform. They will talk to the child's parent if this is not the case, and will follow up with the Headteacher if the situation doesn't improve. In cases of financial hardship, leaders may offer support to resolve the situation.

4.4 Trustees

The Trust Board will review this policy and make sure that it:

- is appropriate for the school's context
- is implemented fairly by the Headteacher
- offers a uniform that is appropriate, practical and safe for all pupils



5. Monitoring arrangements

This policy will be reviewed every 3 years. At every review, it will be approved by the Trust Board.
